

## Report on feedback analysis (Students) - Session 2017-18


The students are the most important stakeholders of Higher Education system. Their feedback plays a significance role in the revision and updation of the curriculum. On completion of the analysis of the feedback received from the students, it was concluded on the basis of the quality and adequacy of the syllabus and the curricula employed. After analyzing the feedback received from the students following conclusions were observed drawn-

- In response to rating the content of the curricula, 39% students rated it excellent, 49% students rated it as good, 11% rated it average and 1% rated below average.
- As far as timely completion of the syllabus by the faculty members is concerned, 63% students said it is excellent, 36% students marked as good and 1% marked average.
- Regarding teachers covered extra relevant topics beyond the syllabus, 45 % students rated it excellent, 51 % rated it as good and 4% rated it as average.

#### Report on feedback analysis (Alumni) - Session 2017-18


In order to make the academic environment of the college more student centric, the college gathers feedback also from Alumni. The college incessantly involves the past students to come forth and share their concerns. Since the students are the fundamental stakeholders of an academic institution, their experiences on Academic resources, Infrastructure, Extra-curricular activities etc. is gathered from the students. The collected and compiled responses is in quantitative terms. The students have marked their experiences on a 4- point scale (excellent, good, satisfactory and unsatisfactory). The responses under each parameter is as follows:

- Classroom, Furniture, Laboratories 70% responded as good, 10% as satisfactory and rest 10% responded as unsatisfactory.
- Library and Reading room- 40% rated Library and Reading room as excellent, 50% as good, and 10% as good.
- Role of guidance of teacher in their overall development= 50% responded as excellent, 40% as good and 10% as satisfactory.
- Other extra-curricular activities- 20% rated it as excellent, 50% as good, 20% as satisfactory and 10% rated as unsatisfactory.
- Electricity, Safe drinking water and Green environment 20% responded as excellent, 30% as good and 30% responded satisfactory and 20% as unsatisfactory.
- Overall rating of the college- 30% responded as excellent, 60% as very good and 10% responded good.

## Report on Feedback Analysis (Faculty) - 2017-18:

The faculty feedback form consisted of five question related to course and curriculum prescribed by the university. Given below are the conclusions obtained by analyzing the faculty feedback for the academic year 2017-18.

- The syllabus is outcome based in the opinion of 83% of the faculty.
- 33% faculties agreed with the statement that the computer facilities are made available for ICT based teaching to the teachers.
- 67% faculty members agreed that the syllabus covers the cross cutting issues like gender equality, environment sustainability etc.
   and students are sensitized towards these issues.
- Courses in the curriculum promote entrepreneurship and students are encouraged and supported in the opinion of 50% of the faculty.
- There is an agreement (50%) to the statement that the college vision, philosophy & objectives are in the tune with Govt. Policies
  and reflected in college decisions.
